Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

The results from the sample taken from the package treatment plant at Pengwern College, on the 14th July show compliance with the permit. However, they also show that the discharge is impacting on the water quality downstream of the discharge.

Further to the investigations carried out that are outlined in [CAR_NRW0042052](#), NRW officers visited the area on 20th July 2023 to check the fungus in the watercourse. The fungus had not got denser but was still present and appeared whiter than observed during the previous week. DO (Dissolved Oxygen) was measured upstream of the discharge, at

the discharge pipe, downstream of the pipe and further downstream, at the end of the sewage fungus. Ammonia was also measured using the snap kit. It was found that ammonia was very low at the upstream location and increased at the downstream sample point. % DO almost halved between the upstream sample location and area around the discharge pipe.

Dye tracing has been carried out by the college on the 26th July and has not shown any misconnections, however, the time taken for the dye to reach the river (< 3 hours) has raised some concerns. NRW suggest that an engineer should attend the site as soon as possible to ensure that the package plant is operating as designed and to carry out a CCTV survey of the pipe and drainage system to further rule out any misconnections or potential damage to the pipe. It is suggested that this is done as soon as possible.
