4. Details of our assessment

Natural Resources Wales were notified of a fire at the landfill waste reception building on 29/01/2023 18:59 by South Wales Fire and Rescue.

Natural Resources Wales were notified of the above referenced fire at on 03/02/23 10:00 by Newport City Council (NCC).

NCC advised that the fire was extinguished quickly and fire water was captured by the site drainage system, although some may have been lost to land.

The cause of the fire is believed to have resulted from antisocial behaviour.

Non-compliances have been scored against the delayed notification which is required within 24-hours of the event and against the emissions to water, air or land due to firefighting water run off.
