4. Details of our assessment

For clarity, this CAR has been completed on the 18/10/2023 but refers to the sample taken at Llanasa WWTW on the 06/09/2023.

There were some power interruptions to the sequencing batch reactors (SBR) which disrupted it's sequence operation was restored quickly but some deterioration was

experienced.

The sample from the 06/09/2023 exceeds the permit limit of 24 mg/l for Biological Oxygen Demand (BOD). The results were 30mg/l.

The LUT (Look Up Table) for Llanasa WWTW is a maximum of 2 samples permitted to exceed the limit for a given determinand. This is the first exceedance at the site within the last 12 months and therefore the score for this sample is (A) Compliant

Dwr Cymru (DC) notified Natural Resources Wales (NRW) of the sample results on the 14/09/2023, eight days after the sample was taken. For future reference, the permit holder must notify NRW within 24hours after an event that may impact compliance such as power failures, via an OpNot (operational notification) which is stated under the Emergency notification within your permit.
