On Friday the 29th of September 2023 a routine site inspection was carried out by the site waste regulating officer.

At the time of the visit site was operational. The site manager was present and accompanied the officer during the site inspection.

The weather was dry, but the ground was wet after the rainfall on previous days.

The site was muddy but there didn't appear to be an issue with standing water or deposits on main road.

The site storage levels were low, and the waste was stored in designated areas.

The yard is also being used to store non waste materials belonging to the site owner.

In general site was compliant with parts of the permit that were assessed.

A review of the waste returns submissions for permit LB3135AL has been completed. I am pleased to report that on this occasion, no issues were found
