4. Details of our assessment

Following the action on compliance report CAR_NRW0041933, to ensure the correct formula is used in relation to the compensation flow that must be maintained while the abstraction is taking place from Oerog springs. An email was received on the 1st July 2023 to show the formula is now as follows:

1.1.1.1 Compensation Flow, Allowable Works Flow

When the duty Llangollen pump is requested to start, the current compensation flow is checked to determine the amount of water available to the treatment plant. This is calculated as follows:

$$\frac{\text{Current Compensation flow (FIT104) m3/hr}}{\text{Current Compensation Flow Setpoint (12.5\%)}} \times (100\% - \text{current compensation flow setpoint (12.5\%)}) = \text{Compensation Allowable Works Flow m3/hr}$$

E.g

Compensation flow = 25m3/hr

$$25 / 12.5\% = 200 \times 87.5\% = 175 \text{ m3/hr}$$

The allowable works flow as calculated by the above compensation flow calculation above shall be used together with the raw water reservoir level calculated allowable works flow to determine the maximum allowable

This was clarified with the consultant used by the operator and found that the formula is setup to manage the required compensation flow while the supply pumps are in use.

While this will provide the correct compensation flow when the pumps continue to be used, there is potential to reduce the flows for a short period of time when the pumps are initially requested to start, while the flows in the watercourse settle to the required compensation flow.

Checks must be carried out to ensure the compensation flow is maintained when pumping first commences. The due date for the action shown above should allow for this to take place during periods of high and low flows.
