Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised by the Natural Resources Wales (NRW) regulating officer to review the submitted Q2 monitoring returns covering the period between April - June 2023. The Q2 returns were received by email on 28/07/23 in compliance with Permit Condition 4.2.3.

Surface Water

Quarterly monitoring of point source emissions to water was reported as per the requirements of Permit Condition 3.7.1(b), Schedule 3, Table S3.3 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1. All parameters were compliant with applied emission limit values (elvs).

In-Field Leachate

Quarterly monitoring of in-field leachate was reported as per the requirements of Permit Condition 3.7.1(a), Schedule 3, Table S3.1 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1.

RMLP9B was found to be at a level of 7.2 meters. This is a breach of the 1 meter above sump base elv. The operator is currently reporting leachate levels at an enhanced frequency to NRW, providing weekly data. The operator is also conducting works to improve leachate levels and management across the site. A Part B notification was received for this breach.

Treated Leachate

Quarterly monitoring of treated leachate was reported as per the requirements of Permit Condition 3.7.1(b), Schedule 3, Table S3.4 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1.

Ammoniacal Nitrogen was reported at 167 mg/l against an elv of 150 mg/l however, once the uncertainty of 12.7% is taken into account this does not represent a breach of the elv. The operator highlighted the high level in a completed Part A & B notification.

COD has seen a significant reduction since last quarter against both the results from the laboratory and the receiving water company. The operator has advised NRW of improvements at the treatment lagoons which, should see parameters consistent with elvs going forward.

Priority Hazard Substances screen was reported in the reporting form as per the requirement for 6 monthly requirement for this screen. The form lists in the Test Method section "Determination of TPH in Water by GC-MS". TPH is a parameter for Total Petroleum Hydrocarbons. The Priority Hazard Substances screen comprises a different set of chemicals. NRW is currently waiting on confirmation on whether a Priority Hazardous Substances screen was conducted. A separate CAR will be raised and a score applied if the screen cannot be evidenced.

Score: (IR3E) Monitoring. Permit Condition 3.7.1(b), Schedule 3, Table S3.4. Score pending the below action.

Action 2: Evidence to NRW that a full Priority Substances Screen was conducted and submit to NRW by 30/11/23.

Groundwater

Quarterly monitoring of groundwater was reported as per the requirements of Permit Condition 3.7.1(c), Schedule 3, Table S3.5 & S3.10 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1.

Landfill Gas in external monitoring boreholes

Monthly monitoring of landfill gas in external monitoring boreholes was reported quarterly as per the requirements of Permit Condition 3.7.1(d), Schedule 3, Table S3.6 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1. The issues identified are discussed below.

CH₄ breached the 1%v/v elv at borehole G12 with a recorded value of 77.8%v/v. CO₂ breached the 1.5%v/v elv at borehole G35 with a recorded value of 29.9%v/v. Breaches of this size are consistently recorded across quarters and the landfill requires investigation and works to control migrating gas. The operator has engaged with a consultant to investigate these issues, identify sources and increase gas control. Notifications were submitted.

CH₄ at 77.8%v/v has generated a score:

Action 3: Produce a gas migration report and submit to NRW.

CO₂ at 21.6%v/v has generated a score:

Action 4: Produce a gas migration report and submit to NRW.

Particulate matter in ambient air

Particulates were monitored and reported as per the requirements of Permit Condition 3.7.1(e), Schedule 3, Table S3.11 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1. All parameters for all required monitoring points were reported as compliant.
