4. Details of our assessment

On Friday the 29th of September 2023 a routine site inspection was carried out by the site waste regulating officer.

At the time of the visit site was operational. The site manager was present and accompanied the officer during the site inspection.

The weather was dry, but the ground was wet after the rainfall on previous days.

The site was muddy but no deposits were seen on the main road.

Storage was discussed with the site manager who stated that the incoming waste streams were steady but not very high.

Fire security was also discussed. Site plan includes the location of the emergency box; however, it was not located as indicated on the plan. The manager was unsure where the box was.

Action: Please ensure the emergency box is placed by the main gate so it's readily available in an emergency. Please comply by Friday the 27th
