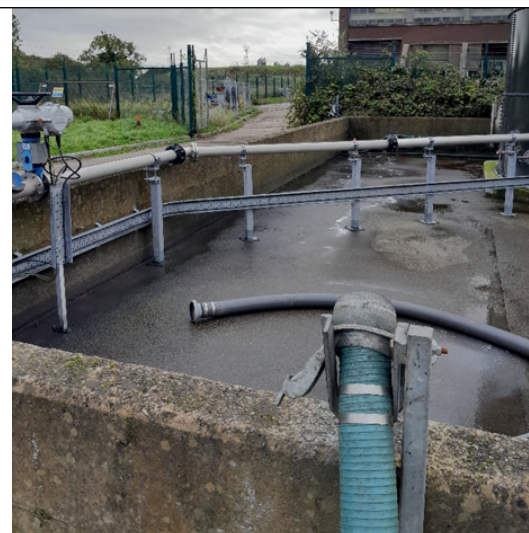


October 2023



Areas of the concrete have been renewed and the bund re-painted yellow.

As part of the continued improvement plan at the site, the old manual pumping system has been replaced with a more modern, automatic switch off system.



The site is very well maintained, and officer Burge had no concerns or actions for the site at the time of the inspection.
