On Friday 13th October 2023 NRW Officer Chris BURGE attended at Olleco Cymru Wales, Stephenson St, Ind Est, Newquay Road, Newport NP19 4PL to conduct a routine site inspection. The weather was dry and sunny at the time of the inspection. Officer BURGE arrived at the site and met with Site Manager Mr. Jason McCANN.

INSPECTION OVERVIEW

On the Previous Inspection in May 2023 Jason McCann explained they had a rolling maintenance plan as well as drain improvement work to be carried out.

This work has now been completed and includes a new entry gate, repairs to the concrete and a roof to the processing area

Jason Explained they will be completing further improvement works which will include the installation of steam cleaners to improve the general cleaning of the site.
