This Compliance Assessment Report (CAR) has been raised in relation to the Q3 monitoring returns.

Monitoring returns Water

The Q3 monitoring returns were received on 25th October 2023 for discharges from W2 emission points in compliance with permit condition 4.2.3.

All reported parameters were in compliance with the ELV's detailed in Permit Condition 3.3.1, Schedule 3(b), Table S3.2.

Waste Returns Q3 2023

Permit Condition 4.2.5 require the operator to submit quarterly waste returns to NRW within 28 days of the close of the preceding quarter. Waste returns for Q3 2023 were received within the stipulated timeframe with no issues identified.
