4. Details of our assessment

This is a follow up CAR form for Compliance Assessment Report CAR_NRW0042631.

There was an action on the previous CAR form to provide a reason for the time taken to notify NRW. The sample was taken on the 29th August 2023 but NRW was only notified of the results on the 9th October 2023. Under 4.3.1 (b) of the Environmental Permitting

(England and Wales) Regulations 2016 permit for Carrog WWTW it states that: Natural Resources Wales shall be notified as soon as reasonably practicable following detection, within the site of the regulated facility of: any breach of a limit specified in schedule 3 table S3.1 including individual exceedances of limits which are covered by condition 3.1.2.

The explanation provided by DCWW is as follows:

"Carrog WwTW has been recently added to the sampling schedule and it appears that the incorrect suspended solids limit was input on the system preventing the automated reported DCWW receive from being generated to flag the sample exceedance. As part of sample performance checks of site, the area scientist noticed the elevated August sample, escalated the missed notification and generated the notification procedure. The permit limit has now been corrected in the system and DCWW do not expect any further issues with any exceedance notification".

Reasons behind the sample exceedance were also provided.

Carrog WWTW is a small works with a Dortmund humus settlement tank that can collect solids on its surface. This is manually de-sludged on a weekly visit and periodically cleaned out but on this occasion, DCWW believe de-sludge was due (the day after the sample was taken) and warm weather and low flows caused more solids to rise than usual, resulting in elevated solids in the final effluent sample. When the operator attended the next day the turbidity was 30 and already improved.

As a consequence, DCWW have increased site visits to twice per week rather than once to allow more frequent monitoring and intervention when required.

The result of this CAR form is (A) Assessed, and no evidence of non-compliance.
