The proposed scheme seeks to improve the standard of defence in the north promenade region of Barmouth, Gwynedd (NGR for site: X 260359, Y 317042)

The works briefly includes:

1: The secondary, or alternative primary wall to be rebuilt structurally and increased by 600m over a length of 1.2km.

2: Tertiary flood wall to be rebuilt structurally and increased by 450mm over a length of 1.1km.

3: Rock toe armour to be provided to protect the primary sea wall and revetment at the north end of the scheme. Remainder of primary defence to be protected by shingle beach nourishment.

4: Refurbishment of existing sheet piles.
