4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards and Hugh Martin of Natural Resources Wales, accompanied on site by operator Mark Tucker.

C1 Staff competency/training

Under condition 1.1.4 the operator shall comply with the requirements of an approved competence scheme. This issue has been raised on the previous two site inspections, however Natural Resources Wales is yet to receive confirmation of your continuing competency. **You must provide evidence demonstrating compliance with this condition.**

C3 Materials acceptance

Under condition 2.3.2 (a) waste shall only be accepted if: it is of a type and quantity listed in schedule 2 tables S2.1. During the inspection tarmac/bitumen waste was identified in the permitted area. This waste type is non permitted to be accepted and as such has been scored as a **category 3 breach of permit condition 2.3.2 a** .

Action - Remove non permitted wastes, and ensure that all wastes accepted onto site fall within Schedule 2 of the held permit.

G4 Reporting and notification to Natural Resources Wales

Under condition 4.2.2 of the permit you are required to submit quarterly returns within one month of the end of each quarter. As we discussed on site, these have been reviewed and as of Q2 2023 a total of 25688.9 tonnes have been accepted onto site.
