Dear Homeowner,

Thank you for your time during our routine site inspection on 17th August 2023. Weather: Dry and Bright.

The treatment plant was operational with no visual evidence of fault, failure or discharge breaking through the surface of the ground. You stated that the tank is emptied on an annual basis.

At the inspection we were notified that the permit holder and homeowner were not the same. You will need to contact the previous owner and have the permit updated and signed over to the new owners. The process can be found on our website:
