Thank you for your time during our routine site visit on the 17th August 2023. Weather: Dry and Bright.

The treatment plant operational, no visual evidence of fault, failure, or evidence of effluent breaking through the surface of the ground.

You stated that the tank is emptied on an annual basis. I am please to inform you that at the time of our inspection, you were compliant with permit conditions. Please continue to
