4. Details of our assessment

This was a pre-arranged site visit carried out by Malcolm Dines, Lucy Geale and Jeremy Goddard to inspect the site for compliance with the Section 59 notice that had a deadline of 31st March 2023. The Officers met with the Owner and Operator, Mark Skitt who accompanied us for the duration of the site visit.

You had been expecting the inspection to be undertaken in the afternoon and so had not finished moving vehicles, as required by the Section 59 notice. Mr. Skitt said that he had been without his new forklift for about 6 weeks as it had broken down, but it had just been repaired and he now had two working forklifts and was able to get back to moving waste.

During the site visit it was clear that, despite the forklift breakdown, significant quantities of waste had been moved off-site since the last compliance visit. Because of the broken forklift, it was agreed that you would move the rest of the waste as required by the Section 59 notice by 28th April 2023.

Permit Breaches

A1 - Specified by Permit - Cat 3; Permit Condition 2.4.1

You have been given this category 3 breach under the above condition as you still have waste materials stored outside the permit boundary. In January 2022 NRW served a Section 59 notice that required you to remove all waste stored outside the permit boundary and due to a breakdown of your forklift you have yet to comply with the Notice.

Action: Comply with the Section 59 Notice **by 12:00 28 March 2023**
