4. Details of our assessment

On 13th February 2023 a routine sample was taken at the site. Following analysis, the BOD and suspended solids concentration were found to be in breach of parameter limits.

The BOD (Biochemical Oxygen Demand) result was 122 milligrams per litre of a parameter of 20 milligrams per litre.

The Suspended Solids result was 38 milligrams per litre of a parameter 30 milligrams per litre.

On review of the results of the previous routine sample taken on 3rd August 2022, it was noted that the suspended solids concentration was 40 milligrams per litre, which was a breach of your licence condition. This further indicates the need to investigate and improve operations.

Action 1:

Undertake investigation to determine the cause of these permit failures and any necessary works carried out to ensure that the permit conditions are complied with.

Action 2:

Provide maintenance records for the site including desludging and servicing of the package treatment plant.
