### 4. Details of our assessment

This CAR form is in response to WIRS ref: 2303913 / SAP ref: 316572812.

Cyclic maintenance caused a blockage in the network and CSO to discharge during dry

weather as described by Dwr Cymru in their storyboard relating to this incident. The discharged sewage in dry weather is in contravention of the following condition:

2.3.1 For the discharge(s) specified in table S3.3:

(a) (i) The discharge shall only occur when and only for as long as the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt and shall only consist of flows in excess of that figure.

It is noted remedial action was taken at the time of this incident and the blockage cleared and CSO stopped spilling. Dwr Cymru state that CCTV is to be carried out once cyclic work has been complete, as per process.

Can you please confirm if the CCTV and cyclic work has been completed?
