4. Details of our assessment

A routine site inspection was undertaken on Tuesday 25th October 2023. Present on site during the inspection were David Ellar (Natural Resources Wales), Terry Perdue, Regan Perdue (Perdue Recycling) Joe Gatley (consultant acting on behalf of Perdue Recycling).

During the visit, options for expanding the current waste operation and several permit options were discussed.

The following observations were made during the inspection:

Waste Storage & Treatment

At the time of the inspection, waste was being tipped and sorted in the building on site. Waste was being stored in skips outside. Some construction and demolition waste was being stored outside in the yard, but this is being stored and treated in line with the conditions of the Environmental Permit as a specified waste.

The site was clean and tidy and good separation of waste types was observed.

Our records indicate that Waste Returns information has been submitted and this information is up to date.

A Fire Prevention & Mitigation Plan has been submitted but has not yet been reviewed by Natural Resources Wales to ensure it meets current guidance.

No non-compliances with the Environmental Permit were recorded during the inspection.
