4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) following the submission of the Q3 Monitoring Returns.

Q3 Monitoring Returns (July to September 2023) - Emissions to Water

The Q3 Returns for July, August and September were submitted on 30/08/23, 02/10/23 and 01/11/23 respectively. **The late returns are in breach of Condition 4.2.3 and have been scored a C4.**

- July 2023 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.
- August 2023 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.
- September 2023 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

Recommendations and Actions

A number of actions and recommendations were identified in previous CARs (Ref: NRW0041875 & NRW0042210). For completeness the status of each action is summarised below.

ACTION 1: Returns are to be submitted as specified in Condition 4.2.3. *within 28 days of the end of the reporting period.*

ACTION 2: Investigate the root cause of the BOD breach and report findings to NRW by 31 August 2023. NRW is yet to receive a response. Please provide findings to NRW **by 30 November 2023.**

ACTION 3: The Operator provided an inventory summarising the use of current refrigerants at the Installation on 26 June 2023. A feasibility study and implementation plan to support the requirements of BAT Conclusion 9 is to be provided **by 15 December 2023.**

As previously advised, a permit variation must be in place prior to the new boiler being operated. It is recommended that a permit variation application for the new boiler be submitted at the earliest opportunity to minimise any delay in operating the boiler.
