4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by the Regulating Natural Resources Wales (NRW) officer to comment upon the Q3 Monitoring Returns.

Q3 Monitoring Returns

Q3 2023 (July - September) monitoring results were submitted to NRW on 25/10/2023, in accordance with permit condition 4.2.3.

Emissions to Water - Emission Point W1

Emissions were tested for Flow, pH, Suspended Solids, Chemical Oxygen Demand, Iron, Chromium, Mercury, Nickel and Zinc. Noted that all measured parameters are below permitted emission limit values (ELV).

Schedule 5 Notification: Part A & B

A Schedule 5 Part A Notification was submitted on Friday 20 October 2023, in response to the treated effluent channel (ETP Channel) overtopping into Flintshire County Council channel (FCC Channel) and at the Broken Bank Pump House during storm conditions (Storm Babet).

A request was made to NRW to agree pumping outside of the permitted pumping times (tidal window) in order to sufficiently reduce the levels in the channel for the duration of the storm event and minimise the risk of flooding at the pump house over the weekend period.

NRW advised that pumping outside of the tidal window would technically be in breach of permit but if the operator was forced to take action to prevent flood damage to property etc then that would be taken into consideration as part of our compliance assessment.

The Operator confirmed that the pump was operated outside the permitted hours on several occasions between 20/10/2023 and 23/10/2023.

Water samples were obtained from both the ETP Channel and FCC Channel prior to commencing pumping and scheduled for laboratory analysis. A Part B Notification was submitted to NRW on 24 October 2023 and included the laboratory analysis results. The samples did not record parameters at concentrations outside of the permitted levels.

An investigation by the Operator identified the root cause to be the *deluge of rain overwhelming the channel*. The Operator proposes to undertake closer monitoring during unusually extreme weather events in order to earlier identify potential issues.

Pumping outside the permitted hours is a breach of Condition 3.1 and has been scored a C3.

Uncontrolled discharge of treated effluent into the FCC channel is a breach of Condition 3.2 and has been scored a C3.

- **ACTION:** The Operator shall review existing surface water and treated effluent management arrangements with a view to investigating options for preventing impact of future storm events. Please provide NRW a summary of your review by **30 November 2023**.
