4. Details of our assessment

The Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) Regulating Officer to comment upon the Q3 Monitoring Returns.

Q3 Monitoring Returns

Q3 2023 (July - September) monitoring results were submitted to NRW on 19/10/23 in accordance with Condition 4.2.3.

Emissions to Water - Emission Point W1 Emissions to water for Q3 were tested on 25/07/2023, 24/08/2023 and 21/09/2023. All parameters were within the emission limit values (ELVs) defined in the Permit (S3.2).

Schedule 5 Notifications Parts A & B

A Schedule 5 Notification Part A & B was received on 27 October 2023 relating to the detection of a leak on the oil switch and pressure relief valves of Chiller 1 on the 26 October 2023. It is estimated that approximately 40kg of R448A refrigerant (N40) was lost. An engineering contractor (Border Temperature Controls) investigated the issue and replaced the oil switch and fan. The condenser was refilled with R448A. The engineering contractor will continue to monitor the Chiller for leaks and undertake preventative maintenance if needed.

A Schedule 5 Notification Part A & B was received on 27 October 2023 relating to a faulty controller on Chiller 3 on the 26 October 2023. It is estimated that approximately 31kg of R448A refrigerant (N40) was lost. An engineering contractor (Border Temperature Controls) investigated the issue and replaced the control unit. The condenser was refilled with R448A. The engineering contractor will continue to monitor the Chiller for leaks and undertake preventative maintenance if needed.

ACTION: Operator to provide NRW with planned maintenance plans and procedure for review by the **30 November 2023**.
