4. Details of our assessment

Introduction

This CAR form has been issued in response to the submission of the 2023 monitoring returns to date (Q1, Q2, Q3) by the operator, and the submission of a Schedule 5 notification of a breach of an emission limit value.

Quarterly Monitoring Returns

All were submitted to NRW within the reporting period specified in permit condition 4.2.3 Reporting.

The reported emissions were within emission limits specified in the permit for the Q1, Q2 and Q3 monitoring period.

Schedule 5 Notifications

Two Schedule 5 Notifications have been submitted for the Q1 - Q3 reporting periods:

- A Schedule 5 notification submitted to NRW on 8 September 2023 gives the measured monthly average dust result for August at A5A (FCCU Catalyst Regenerator) as 51.4 mg/Nm³ against the permit limit of 50 mg/Nm³.
- A Schedule 5 notification submitted to NRW on 9 October 2023 gives the measured monthly average dust result for September at A5A (FCCU Catalyst Regenerator) as 53.5 mg/Nm³ against the permit limit of 50 mg/Nm³.

The Part B section of the Schedule 5 submitted on 9 October included a number of proposed measures to be taken to investigate the root cause of the exceedances.

Compliance: The above results are in exceedance of the emission limit set in the permit for A5A and in breach of condition 3.1.2. A non-compliance score of C3 against the criteria IR3A Emissions to water, air or land has been allocated to these breaches for the Q3 July to September reporting period.

In accordance with NRW's non-compliance scoring guidance, the non-compliance scores for these breaches during Q3 2023 have been consolidated into one non-compliance score.

Action: Operator to implement proposed measures to investigate root cause of the exceedances and to report any findings to NRW, including any proposed remedial actions.
