4. Details of our assessment

Forms A1, Emissions to Air, W1, Emissions to Water and S1, Emissions to Sewer for 1st July to 30th September 2023, were received on 28th October 2023.

All parameters for emissions to air, water and sewer were within their respective emission limit values (ELV).

The reports are accepted.

The flow rates are unusually high this quarter because discharge from the adjacent water tank has been directed into the tank that flows over the V notch. This may have the unintended effect of reducing the measured concentration of substances in the discharge to S1. EnerSys have decided to return the pipe to its original discharge point so that the analysis results remain representative.
