4. Details of our assessment

This was a pre-arranged inspection, primarily as a familiarisation visit of the facility to the new regulating officer for the site, Kathryn Bradshaw and accompanied by Jamie Blythin the previous regulating officer.

We were met on site by the Head of Health, Safety and Environment, the Group Sustainability Manager, the Site Services Manager, and the Head of Engineering.

A brief overview of the site operations was provided, and the function of each job role was explained within the business. We were then taken on a detailed tour of the outside of the site. We did not view the food production areas as part of this site inspection.

We were taken around the effluent treatment plant which discharges to sewer on a trade effluent consent with Dwr Cymru Welsh Water. This process is continually monitored and the waste sludge from this process is taken off site by tanker for disposal by anaerobic digestion. We were shown the waste and chemical storage areas, air emission points, the plant room where the emission monitoring points are located and the location of the penstock valve for surface water drainage. Procedures of the operation of the penstock valve were explained including emergency plans for the site.

No issues were identified during the site tour.

The Site Services Manager provided an overview of the digital management system, which is used to schedule the air monitoring, waste sludge collection, weekly spot checks of emission point W1 and manage the Planned Preventative Maintenance schedule.

Discussions were held about a forthcoming OMA audit which is planned for February 2024 and about Improvement Condition 11, which a separate CAR form will be sent in due course.
