3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

On the 25/9/2023 NRW sampled the final discharge from Ceris Newydd nursing home as part of the Regulatory Monitoring Sampling programme.

1)BOD

Results from this sample showed a Biochemical Oxygen Demand (BOD) value of 227mg/L. The consented value of BOD according to the permit is 20mg/L meaning the result of the sample was 11times higher than the consented value. **NRW has scored this breach as CCS1.**

Action

Ensure that BOD composition in the final discharge is returned to consented value of 20mg/L. In order to do this you must investigate the root cause of the failure and improve operations of the sewage treatment facility. This should be done as soon as practicably possible and please report your findings from the investigation by **no later than 21/12/2023.**

2) Suspended Solids

Results from the sample showed a Suspended Solids value of 64mg/L where the consented limit is 30mg/L. This is twice as high as the consented volume and therefore **NRW has scored this breach as a CCS2.**

Action

Ensure that the volume of Suspended Solids in the final discharge is returned to consented value of 30mg/L. In order to do this you must investigate the root cause of the failure and improve operations of the sewage treatment facility. This should be done as soon as practicably possible and please report your findings from the investigation by **no later than 21/12/2023.**

Natural Resources Wales will await your response and determine the most appropriate enforcement response to the above breaches.
