4. Details of our assessment

A routine site inspection was undertaken on Wednesday 8th November 2023.

During the inspection, the following observations were made:

Site Drainage

The site, generally, appears to be well maintained although following an inspection of drainage channels on site, it was evident that drains were blocked and have not been emptied.

A non-compliance has been recorded against Condition 1.1.1 (a) of the Environmental Permit (Category 4 - No Impact)(Ref:B3)

The Environment Management System (see Point 2.3.3) states that drains and gullies will be emptied, maintained and checked daily for blockages. At the time of the inspection, drains were blocked. There was no perceived environmental impact from this, but in the event of extreme weather and heavy rainfall, surface water may build up and cause an issue.

Please ensure drains and gullies are cleared to allow surface water to run through the site interceptor where potentially polluting materials will be captured.

Waste Storage & Site Boundary

All wastes appeared to be segregated appropriately. A small electrical item was viewed in the scrap metal container and an open container of oil was found behind the gas bottles cage. Please ensure staff are reminded to carry out checks in and behind waste storage bays in the event members of the public leave items out of site that can cause pollution. It was noted that at the time of the inspection, there were several members of public using the site and one site operative.

An inspection of the site boundary was undertaken and the area around the boundary fencing was free from any windblown litter that could potentially escape site. Generally, the area around the boundary fencing was well maintained.

Environmental Permit & Environment Management System

Copies of the Environmental Permit and Environment Management System were presented when requested from the on-site operative (Chris).
