The audit of paperwork for the site was carried out with Mr Isaac Bebb whilst carrying out the Audit at Hendreboeth, the site walk at Brynglas was carried out with Mr Malcolm Bebb.

The site is currently operating 5 biomass boilers, with only 3 listed within the activities.

Variation of permit is required to add the two extra biomass boilers to the listed activities and the site plans to be updated by the 16th February 2024.
