4. Details of our assessment

An unannounced, routine inspection was carried out by NRW officers David Ellar and Rachael Mallinson. During the visit NRW officers met with Nick O'Kelly. Nick O'Kelly accompanied NRW officers around the site. All areas of site was inspected. Weather conditions were very wet and had been so for several days prior to the visit.

No breaches/issues observed at time of inspection. The waste was being sorted whilst carrying out inspection was within permit limits at time of visit. Good segregation of wastes was observed.

Observations:

The site interceptor was recently cleaned and emptied; this is done on an annual basis. A waste consignment note for removal of the effluent was inspected and was compliant.

The concrete is worn on the access to the upper level of the site, Nick O'Kelly explained that there was an ongoing maintenance regime in place, and this would be repaired during the Christmas 'shut down'.

The site was very wet due to the recent rain, this was not affecting the waste operation on site, but a large pool of clean surface water was gathering on the lower part of the site near the office. This pool was being managed by a bund, but thought should be made to see how better to control it.

The electronic site diary was viewed, within this site diary are the considerations for daily checks listed within the permit. Also in the document are links to the waste returns once completed, and other relevant information such as interceptor waste duty of care notes.

No noncompliance's were identified during our last visit (CAR_NRW0037844) so no actions were needed to be assessed.

The TCM qualification was checked and continued competence certificate for Nick O'Kelly was viewed and found to be in date. Continued competence will expire 30/11/24
