4. Details of our assessment

An unannounced routine inspection carried out by NRW officers David Ellar and Rachael Mallinson. During the visit NRW officers met with Gavin Griffiths and David Lawrence (Gavin Griffith Recycling Ltd.) David Lawrence accompanied NRW officers around the site. All areas of site inspected. Weather conditions were very wet and had been so for several days prior to the visit.

No breaches/issues observed at time of inspection. The waste was being sorted whilst carrying out inspection was within permit limits at time of visit. Good segregation of wastes was observed.

No noncompliance's were identified during our last visit (CAR_NRW0037844) so no actions were needed to be assessed.

Observations:

All waste other than green waste, wood waste and specified waste (see permit for specified waste types) was being stored and sorted inside the building. Green waste and wood waste was stored outside on pad under a waste exemption. David Lawrence explained he was aware of the changes coming in next year where waste exemptions may be prohibited at permitted sites.

Recent works had been undertaken by a power company on the pylons to the south of the site and the ground had been disturbed. This works is very near the Afon Llan and is a potential pathway to the watercourse for silt pollution from site run off. No pollution was observed during the visit, but operators were made aware of potential risk.

There was a strong smell of what officers' thought was fiberglass resin in the air during the visit and this was traced to a recently tipped load of waste in the bottom sorting shed. There were plastic buckets in the waste and a some of them still contained trace amounts of resin. David Lawrence explained that they were aware of the contaminated load and quarantine procedures had been invoked and a clean up was underway. Please ensure any non-permitted material is quarantined and removed from site. Operatives were addressing this issue during the visit.

The site was very wet, and pooling of surface water was seen on the hardstanding in front of the treatment building. In some places this was a few inches deep and left unmanaged it has the potential to enter the impermeable pad of the building and provide a pathway for pollution. This was particularly evident at the top end of the site. A clear demarcation between the concrete pad and the hardstanding should be maintained and the surface water drainage on the yard should be addressed. David Lawrence explained that a expansion of the site had ben planned and the whole yard was due to be concreted.
