Breach of Condition 14 (b) of Permit BG0012001 which allows a maximum of 72 mg/l suspended solids discharged. This was exceeded by 6 mg/l on the 22/5/2018. Due to the minor nature of the breach, low environment impact and time since the event no further action is to be taken on this instance.
