### 4. Details of our assessment

Llanrwst STW was visited on 01/11/23 as part of the NRW routine monitoring plan.

While on site it was noted that a distribution chamber between the filter beds and final settlement tank was cracked and leaking untreated water into the surrounding soil (photo attached). This was highlighted to the DCWW staff on site and photos were taken. The amount of water leaking was relatively small, but will escalate to a large volume if left

unrepaired. Please arrange for repairs to be made to contain this and bring the system back to correct operations.
