4. Details of our assessment

During the Compliance Assessment Report (ref: CAR_NRW0041846 dated 07 June 2023) for the compliance visit carried out on 28 April 2023, it was identified that additional ELVs and ELV parts that were not considered to be waste at the time of the original notice had become waste and were now required to be moved to within the permit boundary and that a new notice would be issued to require this action.

At the time of this compliance visit, the new Section 59 notice had yet to be issued and part of the reason for this visit was to ensure that the ELVs and ELV waste to be specified in the new Section 59 notice was up-to-date and take into account any further work that you had carried out in the subsequent two months.

The visit was carried out by Malcolm Dines and Chris Gilbey, who met with Mark Skitt, the site owner who was present for the whole of the compliance visit. The weather was dry and clear.

Permit Breaches

A1 - Specified by Permit - Cat 3; Permit Condition 2.4.1

You were given this category 3 breach under the above condition as you still have waste materials stored outside the permit boundary. There are now just three vehicles you had previously identified as being waste remaining to be moved to within the permit boundary. None of these ELVs are significantly damaged and there is no evidence of leaks. However, following this compliance visit, there are another 7 vehicles in your collection that Natural Resources Wales (NRW) now consider to be ELVs and therefore require you to move into the permitted area, or remove to a suitably authorised facility. Therefore a new Section 59 notice will be issued that specifies certain materials that must be moved from outside the permit boundary.

Action: Comply with the Section 59 notice **by 1 September 2023**

Legal status of this report
