4. Details of our assessment

Unannounced site inspection by Michael Edwards of Natural Resources Wales accompanied on site by Miles Rosser of National Grid Electricity Distribution (South Wales) PLC.

Management

Under **conditions 1.1.1 (b) and 1.1.4** of the permit, the site is required to use sufficient competent persons and resources and comply with the requirements of an approved competence scheme.

During the inspection it was discussed that the Technically competent managers would no longer be subscribing to the WAMITAB certification scheme and would be moving on to another scheme.

Action – As discussed during the inspection please provide information on what competency scheme will be replacing the current certification and provide evidence to demonstrate compliance with conditions **1.1.1 (b)** and **1.1.4**.

Waste acceptance and storage

During the inspection it was noted that all wastes stored on site were in compliance with the conditions of the permit, in line with **condition 2.2.1 (a)** and **table 2.2**.

Site infrastructure was in good condition with no excess water in the bunded area despite recent heavy rainfall in the area. However, some waste oils were stored on upper section of the impermeable surface which did not have a bund to prevent spillage or leaks.

As discussed on site, this has been scored as a **category 3 breach** of permit **condition 2.3.1** as the site infrastructure should reduce potential impacts from a leak or spill.

Action – Ensure that all wastes are stored in line with **condition 2.3.1** and **table 2.3** - *All drums and tanks of waste oil shall be located on an impermeable surface within a bunded area. The bunded area shall have a capacity of at least 110% of the largest vessel or 25% of the total tank/drum volume, whichever is the greater.*
