This CAR form follows up on the actions in CAR_NRW0042355 issued on 4/10/2023

Action complete: Please send copies of the site diary for weeks beginning 21/11/2022, 24/04/2023 and 25/06/2023.

Dwr Cymru confirmed that there is no physical diary for this site, due to no office building on site. The operator records visits on their computer system. The following information was provided:

November 22 visits include 9th, 16th, 23rd and 30th

April 23 visits include 5th, 12th, 19th, 26th with a reactive site visit by our craft team on the 29th to work on

the bio-filter syphon.

June 23 visits include 7th, 14th, 21st 28th planned with an extra visit on the 13th in response to a pollution report and a planned maintenance visit by craft on the 20th.

Action complete: Confirm if a permit to discharge exists for the storm tank discharge.

Dwr Cymru have confirmed that there is no environmental permit for the discharge to the river Ceiriog from the storm tank for this site. Dwr Cymru have confirmed that their permitting department have been tasked to apply for a permit for this site. Please ensure that the new guidance GN021 is followed and that you provide regular updates on the progress of this application. This has been logged on our incident system, ref:2308950. Enforcement action will be considered for this offence and be dealt with separately from this permit and the CARS Compliance process.
