Improvement Condition 7

'The Operator shall complete and submit for approval in writing by Natural Resources Wales:

- A baseline report containing information necessary to determine the current state of soil and groundwater contamination;*
- or*
- Provide a summary report referring to information previously submitted where you are satisfied that such information represents the current state of soil and groundwater contamination;*

so as to enable a quantified comparison to be made with the state of soil and groundwater contamination upon definitive cessation of activity.'

NRW have reviewed the operator's response to the improvement condition and accept the submission.

However, we must advise that as the this Site Condition Report (SCR), and the SCR submitted at the permit application stage are both desk-based assessments (i.e. do not include site reference data) this may potentially cause difficulty when applying to surrender the permit.

Our guidance states that "Unless you are able to provide evidence of the degree of pre-existing contamination, we will have to assume that it was zero, which could have serious consequences for you".

This means that you run the risk of having to remediate any contamination present on the site to achieve permit surrender, including contamination that pre-existed the operation of the permitted installation.

However, if the operator did provide evidence of the degree of pre-existing contamination at the time of surrender, it would be taken into account.

Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment.
