4. Details of our assessment

An unannounced site inspection was carried out by NRW Officer Sally Wakeford and Jolene Lewis on 08 November 2023 at Stenor Limited EPR/AB3392HL. The weather was dry at the time, although had been preceded by a period of heavy rainfall.

We were accompanied on site by John.

The area to the front of the site is screen and ready to go out, the pile along the bund to the right-hand side of the site is unprocessed. There is also a large stockpile on the left which is screened and ready to be used. The site was well organised, with a roadway leading to the rear of the site.

Water was pooling on the site and filling the roadway. However, during periods of heavy rain this is expected as additional excess water enters the site from the road. The bund to

the rear of the site was containing the runoff and ensuring no pollution or silty water was entering the nearby streams or farmland. This water will eventually soak away through the hard standing.

John informed us the hardstanding is regularly maintained to ensure water percolates suitably.

The large pile to the left of the site has a small “wall” built on the top to show the edge, to ensure no waste or material is pushed beyond this wall. The slope of the stockpile is away from the bund which sits alongside the stream. There was no evidence of waste slipping into the stream and no cracks were evident on the face of the waste.
