Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Due to the effluent discharge pipeline failure on 17th November 2023 all processes on the installation are shut down so no process effluent is generated. However, in the event of rainfall there will still need to be a route available for the discharge of surface water, otherwise there is a risk of site flooding. Solutia have therefore requested use of a temporary discharge route via a local culvert and re-en direct to the River Usk on the western side of the installation. Solutia have previously used this discharge route with permission from Natural Resources Wales (NRW), see CAR_NRW0039673 for full details.

Permission is granted by NRW to use this temporary discharge route for site surface water subject to the following conditions:

- 1). On any day when there is discharge of surface water using the temporary route, a day composite water sample is taken. This must be analysed for all parameters as detailed for Emission Point W2 in the permit and the results reported to NRW in accordance with the current permit reporting requirements defined in Permit Condition 4.2.3.
- 2). Solutia to provide notification to NRW if the period when the temporary discharge route will be used is likely to continue after 4th December 2023.

In all other respects the permit conditions are unaffected.
