4. Details of our assessment

Officer Chris Burge attended at Berthgron Quarry Transfer Station, Nelson to complete a routine, unplanned compliance inspection of the permit EPR/UP3695FZ held by Valley Recycling Limited. The weather was wet and cold at the time of the inspection

SITE INSPECTION

At the time of the inspection the site was operational, staff on site were undertaking a clean-up of the area. Staff were emptying the bays and sweeping before returning the waste back to the separate waste bays.

Photo 1 shows the machine being used to clean the bays



Material is then stored before being taken off site to a larger permitted facility.

All waste is stored in separate bays once it has been sorted

Image 2 shows a bay containing wood waste



The site is in good condition with a large concrete area where the waste is sorted which was in good condition, the site has sealed drainage which is checked daily.
