4. Details of our assessment

On Tuesday 14th November 2023 Officer Chris Burge attended Maindiff Court Farm, Abergavenny to complete a routine, unplanned compliance inspection of the environmental permit EPR-HB3597TC. The weather was wet and cold at the time of the inspection.

SITE INSPECTION

At the time of the inspection the site was operational, although due to the weather, site was not processing. There was a small amount of new green waste at the site awaiting processing. The operator explained that inputs have reduced since the weather has changed however this is perfectly normal.

Photo 1 shows the fresh material awaiting processing



Photo 2 shows the newly processed material. After checking for contaminants such as plastic, this is stored at the lower yard before being shredded.



Officer Burge then inspected the upper yard. This is where the material is then brought, where it is stored in windrows and then put through the trommel to remove over sized items and any small contaminants that have been missed.
