The CQA Validation Report for the installation of the new leachate tank was received via email on 06/11/23. This report was accompanied by a new leachate system plan and an updated Leachate Management Plan.

The Leachate Management Plan had been updated to reflect the installation of the new leachate tank.

The CQA Validation Report had been submitted due to an applied action. Thank you for this submission. Natural Resources Wales (NRW) is broadly satisfied with the contents of the report. Before final acceptance however, we request further details regarding when the operator last inspected the concrete surfacing, to ensure its integrity and load bearing is suitable for the new tank.
