4. Details of our assessment

The site was inspected with Mark Timmins, Head of Maintenance Delivery for Travelodge and the following points were noted:

The outer gate from the public area wasn't locked. Mark was going to attend to this to prevent the public gaining access.

The actual gate to the sewage works compound was locked.

Access around the treatment plant was fine, with no build up of leaves etc on the paths.

The control panel to the treatment plant showed a red light as in the attached photograph number PB140180. Mark provided an e-mail from the maintenance company after the visit to show that this light was supposed to be on all the time.

The biodisk was seen to be rotating, i.e. in working order.

The effluent quality looked good - as seen in the attached photo number PB140181. After the visit Mark provided an analysis sheet of a sample taken by Willow Pumps Limited of the effluent on the 26th of October. This showed that the discharge was compliant with its permit on that date.

Two manhole covers in the grounds outside the treatment plant compound were checked. These has been a concern previously. The manhole covers were seen to be safely in place.

A small diameter pipe was seen leading from the Burger King kitchen and joined a rainwater downpipe at a gulley. A query was raised as to whether this was a misconnection, or not. Mark checked on this after the visit and confirmed that it was a drain from an ice maker. This matter was therefore considered closed.

It was concluded that the treatment plant was in working order and appropriately maintained at the time of inspection.
