4. Details of our assessment

The Seaquarium first reported of having problems with their outlet pipe/soakaway apparatus on the 23rd of May 2023. It was reported that water was backing up at the

Seaquarium and that water was observed to be rising to the existing beach level in the approximate location of the soakaway.

Natural Resources Wales have reviewed the report that was created as the result of a CCTV survey of the pipe on the 25th of May 2023. Debris and standing water were found within the pipe which obstructed the head of the CCTV unit from going any further than approximately 4.75m downstream.

Upon investigation of the soakaway, the geotextile was found to be deteriorated. As a result, the existing material was found to be contaminated with finer silty material.

Please carry out your own investigations and necessary works to determine that the soakaway is fit for purpose and review your maintenance schedule if necessary. Ensure that the discharge passes through the soakaway.

Please complete all necessary works before April 2024.

Please provide an update to NRW on your plans for maintenance/replacement before the end of December 2023.
