4. Details of our assessment

This compliance review was carried out following the expiry of the deadline to complete actions on-site required by CAR CAR_NRW0039177. There was no site attendance by Natural Resources Wales (NRW), photographs of site were submitted by Marc Davies on 8th April 2022 at the request of Malcolm Dines.

Other MattersOutstanding Compliance Actions

The photographs supplied show that there has been a significant improvement at the site since the compliance visit in December. There is now no evidence of waste being stored outside the permit boundary and wastes stored inside the permit boundary are either stored inside the building or within skips outside the building but within the permit boundary.

Further improvements have been made to the staffing of the site as you have now employed a new full-time member of staff employed.
