4. Details of our assessment

On Monday the 13th of November 2023 Natural Resources Wales officers carried out an unannounced routine site inspection.

Nicki James, site owner, was present and accompanied officers throughout the visit.

The weather was dry with high winds.

The site was operational with an operative manually sorting waste streams on site. The site appeared well organised with no amenity issues noted (odour, litter, noise).

Waste segregation and storage:

Waste was being segregated into separate piles. Gas cylinders were stored appropriately in a locked cage on site.

Officers notice waste mattresses on top of a skip. Mr James said he was arranging for all of them to be collected in the next few weeks.

Waste returns

The officers discussed waste returns with Mr James. All quarterly submissions for 2023 have been received by NRW. It was noted that the "site information" tab was missing the TCM - Technically qualified manager's details.

The outgoing waste codes seem to be incorrect. Once the "17" codes are treated/sorted at a waste transfer station they should fall under the "19" code. Please revise and submit subsequent waste returns with correct codes.

Action: Please provide the missing TCM information by 12th of December 2023
