4. Details of our assessment

Linda Warrick of Natural Resources Wales met with Howard Stevens of Swansea Bay University Health Board (Estates) on the 23rd of November 2023. LW arrived on site at 10:30am. The weather was dry. The inspection was pre-arranged and forms part of NRW's Waste regulation inspection regime for permitted sites.

LW and HS discussed the current clinical waste management issues within the NHS. Time was spent discussing the pre acceptance process for satellite sites that classify waste moved into the permitted area and further afield. It was arranged for LW to visit some of these sites in the New Year.

HS forwarded LW a full list of the sites controlled by SWUHB. We also discussed some of the cross over responsibilities with Shared Services. LW is currently collaborating with Shared Services to prevent the duplication of work and to ensure clinical wastes are correctly classified.

It was also highlighted the fragile nature of the sector with over reliance on specific companies, which when there are operational and maintenance problems, can have an impact on the permitted site.

COTC

HS is the technically Competent Manager for the site. He has recently passed his Continuing Competency Assessment. This is valid until the 13th of November 2025. The certificate had been filed for our records.

Permitted Storage Area

HW and LW visited the permitted area. There was small amount of clinical litter waste namely surgical gloves visible. Please ensure housekeeping is kept to the high standards seen in previous inspections.

Colour coding of drains was fading so please ensure this is refreshed to ensure the different drains are easily recognised.

The Euro Carts were clearly labelled and they were all in good condition. They were all tagged with the appropriate clinical waste classifications. They were all locked and secure. LW inspected a number of sharps containers, and these were all signed and dated appropriately.
