4. Details of our assessment

As per email received by Lloyd Ayris on 15 December 2022, you informed NRW that pumps had been replaced by DEFLO and that the works was operating correctly. However, on the 26 June 2023 our sampling indicated an ammonia reading of 5.76 mg/l against a limit of 5 mg/l and again on 19 September 2023 our sampling indicated a n ammonia reading of 10.9 mg/l. This latest sample is more than double the permitted limit. Please can you investigate the reasons for these failures and inform NRW of your findings and actions taken by 3 January 2024. In addition, can you please also submit records for servicing of the plant for the previous two years.
