Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

As a result of this variation by the operator there will be 200,000 broiler places housed in four sheds. Birds will be brought on site as day olds chicks to an age of thirty seven days. Approximately 50% of the birds will be thinned at day thirty of the cycle. The sheds will be empty for twelve days to clean the houses and prepare for the next flock arriving on site.

The schedules specify the changes made to the original permit.


