4. Details of our assessment

NRW Hazardous Waste Officer Gillian Coates and ARCADIS consultant Lydia Potter visited G F Grigg Ltd site to sample materials produced on site under Environmental Permit GB3632AS.

Weather conditions at the time of the inspection were overcast with showers and visibility was good.

Officers were accompanied during the visit by Graham Grigg in the absence of TCM Fraser Grigg who was unavailable at the time of the visit.

Note: Fraser Grigg was emailed on 21/11/2023 to ask for a stockpile plan and confirmation of the EWC codes of the wastes taken into and out of the site. A response regarding the EWC codes has not yet been received.

There was no activity taking place on the permitted site at the time of the visit.

10 samples were taken from the pile of sieved soil which was being stored under cover.

A portion of each of the 10 samples was placed in a sealed bag and given 15 minutes before being checked for the presence of Volatile Organic Compounds (VOCs). None of the samples gave a reading for VOCs.

While the sampling and testing took place the permitted site was checked for permitted materials and litter.

C3 - MATERIALS ACCEPTANCE

All wastes stored on site were checked and were compliant with Schedule 2 Table 2.1 of your permit.

F3 - DUST, FIBRES, PARTICULATES & LITTER

The site was clear of any accumulation of litter.

Following the site visit checks were made on our records for your waste returns.
