4. Details of our assessment

This was a pre-organised visit to discuss future permitted activities and their scope within the site current operations. Senior Officer Steven White met with Paul Roberts, Julian Cope, Nicholas Fischer and later Andy Dutton. After a brief introduction in the office we carried out a tour of the current and proposed site activities, due to the commercial confidentiality of some of the discussions on site reference to these will be in separate correspondence to this CAR form.

The site was exceptionally clean and tidy and well organised, the incoming new rules on source segregation of wastes have already been adhered to with separate bins for almost all waste produced by Brother on site.

Treatment of waste printer toners was observed and discussed, there were no issues with the treatment operations observed during the inspection.

Bulkier waste items are stored in larger skips to the rear of the building, these were all to currently-permitted sites for waste recovery.

In the car park area to the north of the site a new prefab building has been constructed, this is to house wastes and products produced by the company. The building is situated on a sealed tarmac area with some surface water drains nearby, however the building itself is not fully sealed. It was advised to invest in some drain blocker mats (such as Dammit) to ensure that if there is an accidental spill this will be contained with the site yard and not enter the nearby drain system.

Prior to the visit Waste Returns for 2023 were checked, there were no concerns raised with these.
